The above Order has been passed to give consequential effect of the Order of the Hon'ble High Court of Bombay at Goa for AY 2009-10, whereby closing stock AY 2009-10 was increased and accordingly opening stock for AY 2010-11 was adjusted and thereby reducing taxable profits for said AY.
